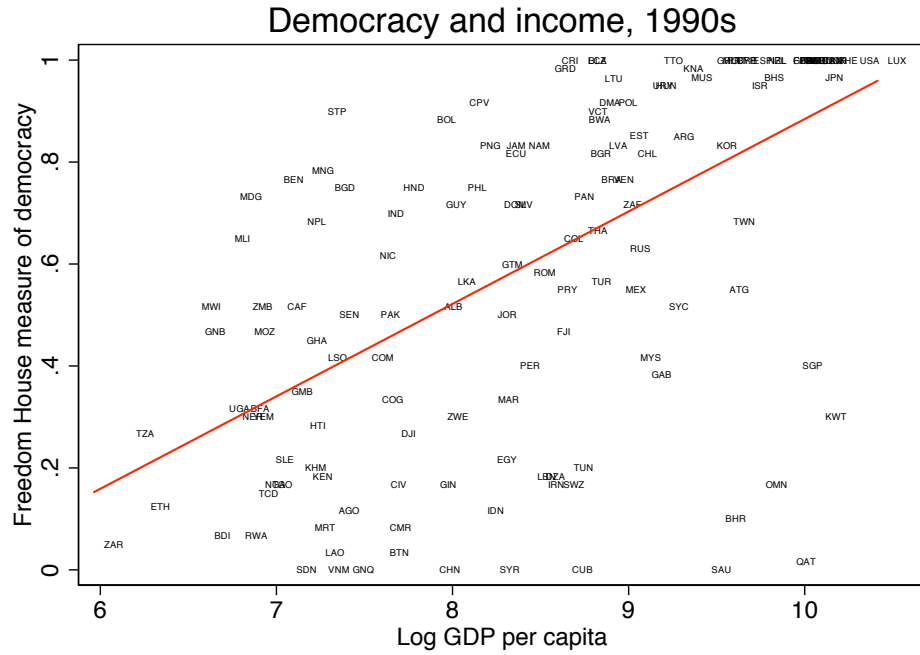


Figure 1: Democracy and income, 1990s.
